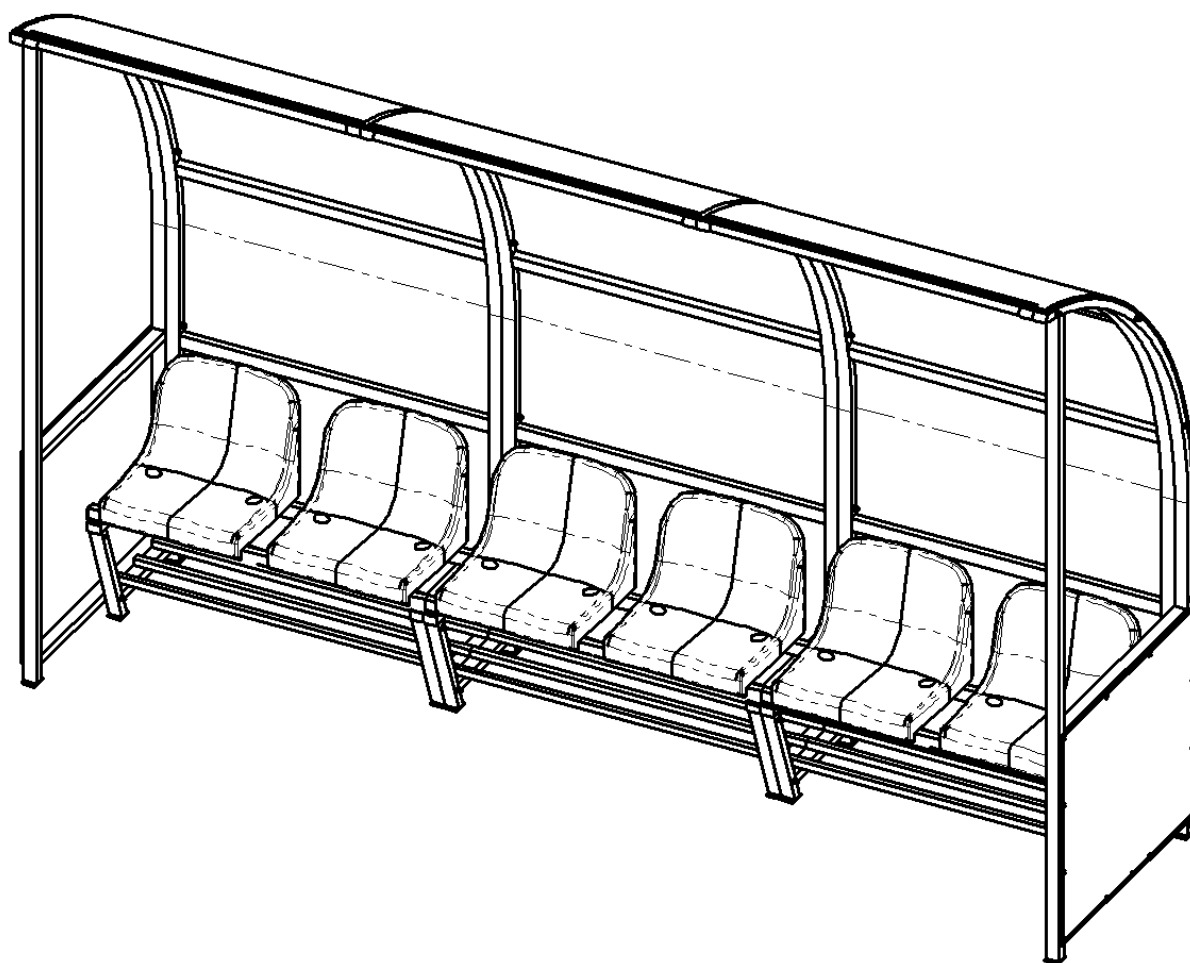

Chapter 1. INTRODUCTION

Purpose and content of this document. This document is an operational document for sports and gaming equipment (document code according to GOST 2.601-95: RE), and contains general description of the product and its operation, as well as information on installation, intended use, maintenance, transportation, storage of the product.

Level of specialised user training. To use the product, each adult user is obliged to:

- Read and understand this document in detail;
- Strictly adhere to the requirements and recommendations of this document.

Distribution of this document for product modifications. The manufacturer can make changes to the product design to improve its performance, change the design, etc. This document may not contain a description of such changes, but applies to the following modified products.

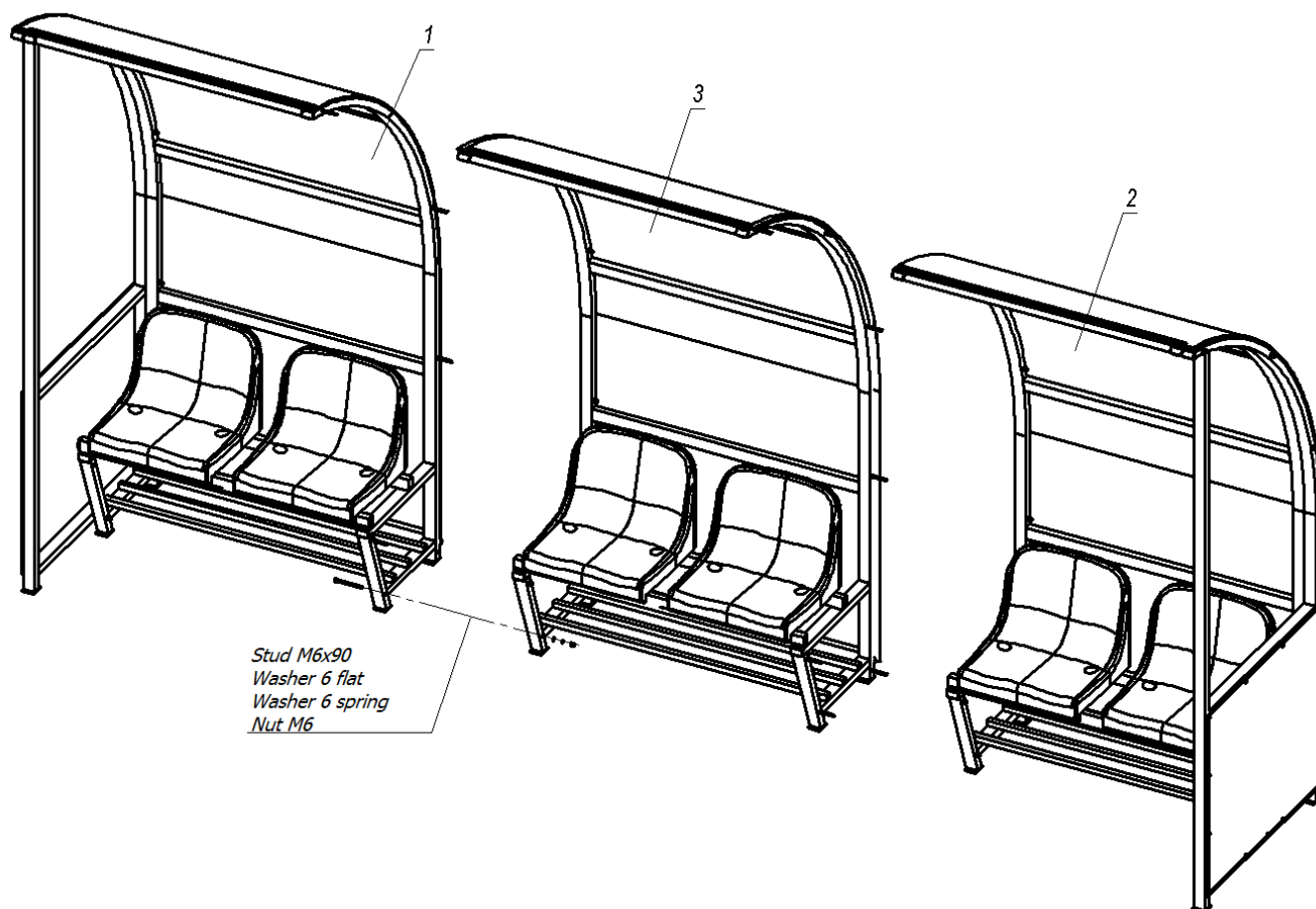
Chapter 2. DESCRIPTION AND OPERATION

Product purpose. The product is intended for recreation and protection of people from adverse weather conditions. The product is intended for use outdoors.

Product characteristics.

Product composition. Product appearance and its main components are shown in the following picture 1.

Structure and operation. Substitution bench is a seat with a cover and is designed to protect users from weather conditions (rain, snow, wind, etc.).

Tools and accessories. The product does not include tools required for assembly and installation of the product.

Marking and sealing. The product does not contain any special fasteners (seals).

Packaging. The product is supplied in plastic packaging. Additionally, the product may be packed in cardboard. The plastic packaging must be retained by the Buyer (the product must be returned in its packaging only). There are no seals on the packaging.

Chapter 3. USE FOR THE INTENDED PURPOSE

Operational restrictions. The product must be used for its intended purpose.

Preparing the product for use. Before use the product must be installed in full compliance with the requirements of this document and other product assembly documents (if supplied). Product appearance is shown in the picture 1.

Product assembly and installation procedure. If the product is delivered disassembled, it must be assembled before use. A scheme of the product's disassembly is shown in picture 1. The product should be placed on a relatively flat, hard surface. The sections of the product are joined together with the fastening kit supplied with the product (M6x90 stud, flat washer 6, spring washer 6, cap nut M6).

Chapter 4. PRODUCT MAINTENANCE

The maintenance of the product implies, first of all, the responsibility of the user to comply with all recommendations provided in this document, starting with a daily inspection of the external condition of the product.

Before using the product, check its functionality and absence of breakdowns (damage) - in case of product breakdowns, its complete or partial inoperability, the use of the product is prohibited.

Chapter 5. STORAGE

Preparing the product for storage and removing it from storage. *WARNING!* The product is designed for continuous use for its intended purpose (considering the limitations specified in this document) after installation.

If circumstances require that the product is not used for a long period of time, we recommend that you observe the following storage conditions (the list of storage conditions is not limited):

- place the product in a closed, warm, dry room protected from direct sunlight;
 - protect the product from external factors (dust, water splashes during cleaning, etc.) with a large plastic bag, leaving space for free air circulation;
 - take all other measures to preserve the appearance and properties of the product during storage.
- When removing the product from storage and starting to use it, observe the following recommendations:
- remove protective materials (polyethylene, paper, etc.) from the product;
 - remove dust and other contaminants from the product surface;
 - check the product for proper operation;

Chapter 6. TRANSPORTATION

The product is transported in its packaging. The method of packaging should be the same as the method of packaging used before the product is first assembled. Transportation must be carried out in such a way to protect the product in the packaging from external factors (rain, snow, sunlight, water, humidity, etc.).

Chapter 7. DISPOSAL

After the end of the product's service life the Buyer independently determines the procedure for its further use. If you decide to dispose the equipment, please contact the seller of the product or specialised organisations.
